The 'Bite Unit' submitted for testing by Bisley Office Furniture, has satisfied the relevant requirements of BS EN 14074:2004 Office furniture (Tables and desks and storage furniture. Test methods for the determination of strength and durability of moving parts).

*As the 'Bite Unit' submitted for testing is representative of the whole range of the same construction, based on the evidence supplied by Bisley Office Furniture, SATRA would also consider the other smaller units in the range to also meet the relevant strength and stability requirements of BS 4875: Part 7: 2006, at Test Level 4 (except for Clause 6.2.2), BS 4875: Part 8: 1998 (except for Clause 7.2.1), BS EN 14073: Part 2: 2004 (except for Clauses 3.5 and 3.6.2), BS EN 14073: Part 3: 2004 (except for Clause 5.4) and BS EN 14074: 2004. (Any changes to the range will invalidate the certification).*
